2. The tender will not be accepted from the firm to whom the document is not issued by the Board.
3. The Board takes no responsibility for delay or non receipt of Tender Document sent by post either way and also reserves the right to accept; or reject any or all the tenders in part or full without assigning any reason thereof.
4. No bid document will be sold after the last date of sale of Tender Document or between the extended period of opening date, if any.
5. The bidder is expected to examine all instructions, forms, terms and conditions and specifications mentioned in the bid document. Failure to furnish all information required by the bid documents or submission of a bid not substantially irresponsive to the bid document in every respect will be at the bidder's risk and may result in the rejection of it's bid.
