

4. Para C.2(b)(i) at page 13 shall be replaced and read as *Engineering/Technology/Science: Environmental/ Chemical/ Plastic Polymer/ Sustainability.*

5. At form-1 page 19 of the EOI following document shall be placed in the list of documents: *certificate of accreditation in case of QCI-NABET accredited institution.*
6. At form-6 placed at page no 24, the number of coordinators shall be read *as 3* in place of 5.
7. At form-7 placed at page no 25, *the CV of Project Assistants shall be incorporated.*
